From the Chairman

With an unemployment rate of 8% and a university graduation rate of 11%, Turkey harbors immense growth potential. The country should undertake strategic R&D investments to nurture its economic cost and enhance its regional power through export-driven policies.



Disempowered macroeconomy

The year 2014 was a challenging period due to global economic uncertainties as well as general instability in the Middle East and Ukraine. The main factor affecting the global economy which grew 3.3% in 2014, were the Federal Reserve's decision to end its bond purchases in October, the weak performance of the US stock in international markets and the fall in oil prices.

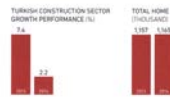
Fed Decisions usher in a new period for the global economy

In parallel with the improvement of oil prices and employment figures, the Fed decided to end its quantitative easing through bond purchases, which led to a sharp increase in international markets. Emerging economies such as Brazil, Russia, India, South Africa and Indonesia, which became victims of deflation in international markets during the global financial crisis, began to show signs of recovery. It is estimated that year-over-year export demand for these countries, coupled with the end of deflationary markets and developed ones, especially the USA, in this period, emerging economies will face difficulties in securing foreign financing and as such have to further operate in sectors that will boost their competitive edge in international trade flows, which have a special place among emerging economies with its high savings rates, was also affected by the global economic sluggishness, and grew by only 7.4% in 2014.

Turkey preserves its macroeconomic stability

Despite a sharp fall in the global economy, Turkey kept its momentum in 2014 and grew by 2.4% in its gross value added (GVA) in 2014. Turkey's current account deficit (CAD) rose to USD 10 billion mark, as a result of the drop in oil prices in international markets, as well as the macroeconomic measures implemented by the government. Still, thanks to international trade agreements and an investment grade rating, Turkey can afford to offer domestic and international near-term players a favorable investment climate, despite a rise in inflation and unemployment figures.

With an unemployment rate of 8% and a university graduation rate of 11%, Turkey preserves immense growth potential. The country should undertake strategic R&D investments to enhance its economic cost and enhance its regional power through export-driven policies.

Being in the middle and eastern part of the world, Turkey has a strategic location and a growing market. The country preserved its macroeconomic stability and growth outlook, which in turn has boosted the motivation of foreign players, including us to implement their investment plans.

Construction sector still by exchange rate fluctuations

The Turkish construction sector, which has been the heart of TORUNLAR REIC's operations and future plans, grew by 2.2% in 2014. Having expanded by 7.4% in the previous year, the sector has not been able to fully recover from the fluctuations in exchange rates and the global and domestic macroeconomic conditions. The sector had an investment volume of USD 10 billion and had a turnover of 1.8 million euros. As such, the sector maintained its strong development momentum. In Turkey, similar to other countries, there is a strong and steady development in infrastructure, mainly in roads, bridges, and other large-scale infrastructure projects, which will have a significant impact on the housing sector in the long run.

Private sector projects drive the industry forward

In 2014, the private sector continues to be the main driver of growth in the construction industry. Although in public sector construction spending declined this year, thanks to the favorable impact of the law of incentives related with urban transformation and residential housing projects, private sector construction expenditures went up 9.4% in comparison to 2014.
